

Dear Little Creek Farm Conservancy friends at Little Creek Horse Farm & Park,
To maintain the health and safety of the barn community,
including protection of staff who must be here,

**Effective immediately (3/16/2020), the Park is CLOSED
to the public until further notice.**

***Every boarder, lessee, authorized rider, vendor, program, instructor,
lesson student READ TO END:***

- In accordance with CDC guidelines, we are requiring that anyone who has traveled of any of the 5 countries on the CDC warning list (currently Italy, Japan, South Korea, China and Iran) or any of the high risk US States – more will likely be added soon - do not come to Little Creek Horse Farm for 14 days following their return to Atlanta. Similarly, if you have been around someone who has had (or is suspected to have) COVID-19, you should stay away and monitor your health for 14 days.
- If you are a boarder and need someone to check on your horse(s) during a time where you are staying away because of this requirement, let Jamie know! The barn community is here to help you.
- Stay home when you or your family member is sick. If anyone has a cough, shortness of breath, or an elevated fever beyond 100.4, we ask that you stay home until symptoms are gone and a normal temperature has been maintained for over 72 hours (3 Days) without the use of medication. If you have been diagnosed with (or suspected to have) COVID-19, you should stay away for at least a week, to include at least 3 days after the fever goes away.
- Little Creek Farm has asked that ALL programs consistently clean all shared helmets, crops, reins and other shared equipment with disinfectant daily or more frequently as necessary. Please continue to be extra diligent with this procedure.

Boarders & Lessors are allowed to visit the Barn within the following guidelines:

- You are feeling well. No household members are ill.
- You sanitize hands at entrance to barn.
- You may NOT bring siblings, children out of school, or other visitors etc. with you to ride. No spectators until further notice.

Lesson Students are allowed to participate in lessons within the following guidelines:

- **Aged 14+**
 - You are feeling well. No household members are ill.
 - You sanitize hands at entrance to barn.

- Parent/caregiver may drop at door, and wait in car/parking area.
- **Under 14 years of age:**
 - You are feeling well. No household members are ill.
 - You sanitize hands at entrance to barn.
 - Parent/Caregiver *ONLY* must walk student in, then return to car/parking area.

Stride Ahead is currently closed to clients. Please check their website/contact them for additional details.

Additional NOTICES:

- Wash Stalls/Crossties are CLOSED until further notice. Tacking/untacking must be done in stalls.
- There will be Clorox bottles and paper towels at each entrance, please wipe down things you touch frequently while at the barn and be sure to sanitize your tack after use if shared among multiple riders.

In addition to the County's restrictions, the Conservancy has made the following adjustments to programming, in effect until further notice:

- All programs, including Hands on Horses and Volunteer Information Sessions, are cancelled.
- All scheduled volunteer engagements are cancelled.
- Committee meetings should be conducted online, or if not possible, cancelled or held off site, and following all recommended social distancing guidelines.

Like you, we are closely monitoring the updates from the CDC, and additional information will be provided as necessary. In the meantime, thank you for doing your part to ensure the safety and well-being of those around you! And thank you for supporting this special Park and its programs.

We hope that everyone stays healthy and is able to enjoy this beautiful spring, despite the disruptions to our lives and schedules. With warm regards and gratitude for our community,
